

## Financial Assistance available in Delhi

1- **The IRCH** “poor fund” ---- Patients get medical assistance of Rs. 10,000= only. The patient should approach room no. 151 with the concerned doctor's recommendation on his / her OPD card .

2- If a patient gets adopted by the **Cancer Foundation** in IRCH, he / she is entitled to Rs. 15,000= assistance only. For this help the concerned doctor recommends the case and if it is passed, the patient gets help in the form of medicines.

3- **Prime Minister's Relief Fund (PMRF)** South Block gives Rs. 30,000= or half of the actual expenses incurred by the patient, as per the decision of the concerned committee. For this the patient must submit the following documents--

(a) Income certificates of the earning male members of the family. The earning male members should be between the age group of 21 to 59 years. In rural areas Tehsildar and in urban areas SDM can issue such certificate.

(b) Application on a plain paper.

(c) Doctor's estimate.

(d) Attested copy of Ration Card, BPL / APL.

(e) An MP's recommendation letter.

The patient applies directly to the PMRF

4- **Health Minister's Discretionary Grant**- For other than BPL card holders but from economically weaker section, this grant can be procured. For this application can be procured from the Nirman Bhawan. The following documents have to be furnished along with the application --

(a) Original income certificate

(i) rural areas tehsildar can issue it

(ii) Urban areas SDM can issue it.

(b) Attested copy of Ration Card containing name of the patient and the patient's relation with the card holder

(c) Doctor's estimate for the treatment

Note 1-- As per the ration card if no family member mentioned in the ration card is more than 21 years , the income certificate of the card holder will do. In case there are other male members more than 21 years, family income from all sources should be submitted.

Note 2 – Committee of AIIMS can sanction up to Rs. One lac. If the doctor's estimate is more than one lac, the form will be sent to the ministry and the correspondence will be between the ministry and the patient's family. When the letter of sanction reaches the patient's family, they should approach the hospital with the letter.

**5- Patients falling in BPL** (= Below Poverty Line) can get all hospital charges exempted AIIMS and IRCH. For medicines etc. the patient, whether BPL or low income group, should request and ask their concerned doctor if they can be helped from the hospital.

**7- RAN = Rashtriya Arogya Nidhi** in Nirman Bhawan. Documents required ---

- (a) Doctor's estimate
- (b) BPL Ration card's attested copy
- (c) Income Certificate

Note - This scheme, if passed, may give 100% cost of treatment

**8 – DAN = Delhi Arogya Nidhi = Delhi Administration Illness Fund** - gives medical assistance from Rs. 30,000= to Rs. 1.5 lacs. For this forms can be procured from Lok Nayak Hospital, Delhi Gate.

For help for this scheme approach room no. 9 in AIIMS and room no. 151 in IRCH .`

The following proofs must be submitted

- i- Patient must be a resident of Delhi and has to furnish domicile proof of residing in Delhi continuously since 1-1-2008 to date
- ii – Patient should belong to a family living “Below Poverty Line”
- iii- Treatment should be from a government hospital in Delhi.
- Iv – The patient should be suffering with life threatening disorder.
- V – Two photos of the patient dully attested by the treating doctor

Vi – A copy of the BPL ration card to be submitted and the original should be shown for verification of the fact that the Patient belongs to a family living “ BPL “. In case ration card is not available Income Certificate issued by the area SDM to be submitted in original

**9- Dr. Ambedkar Medical Aid Scheme** - The documents required are ----

i- Doctor's estimate for the treatment.

Ii – Ration Card BPL / APL

Iii – Income Certificate ( Should not exceed Rs. One lac per annum )

Iv - This scheme is only for SC / ST

V – MP / DM / DC's recommendation.

vi- 75 % cost of estimate is given in two instalments

( a ) First before surgery ( b ) second after surgery

**10 – Chief Minister's Fund** - The following documents must be submitted

I – Doctor's estimate for the treatment.

ii- Ration card BPL / APL

iii – Income Certificate.

Iv – Application letter by the patient or attendant.

## **1 RAILWAY CONCESSION**

Railway concession form can be procured from room no. 9 of the main o.p.d. i.e. Rajkumari Amrit Kaur Building .The I.R.C.H.

Patients get it from room no 151 in I.R.C.H..For this they have to show their O.P.D. card showing their next visit to the hospital.

This facility is available to cancer patients only

From hospital to home (address mentioned on the hospital card) and home to hospital Concession is given to the patient and one attendant. In

case concession is given , the patient gets 100% concession and the attendant gets 75% concession on railway fare. Reservation is not included

The concession rate for different classes will be different
